Greetings to all current and new parents of Harker students!

As the finance office prepares to do our annual tuition billing, we would like to take this opportunity to thank you for your continued patronage and support of the school through your wonderful volunteer efforts, and your generous donations.

The annual billing process for fall tuition will be nearly the same as last year; all accounts will be billed for the annual fall tuition on June 1. All our continuing and new student families will be billed under the terms of their respective contracts as of June 1, with payments due on or before June 15, 2024. This letter will serve as proper notification as to amounts, payment methods, and payment locations for the 2024-25 annual tuition.

To clarify the amounts due, all families will be billed for the *difference* between their child's grade-level *tuition amount* and the *deposit paid* earlier in the year (\$2,500).

The **Tuition Schedule** for the **2024-2025 School Year** is as follows:

Transitional Kindergarten: \$43,750 - \$2,500 = \$41,250

K - Grade 5: \$48,500 - \$2,500 = \$46,000

Grades 6-8: \$57,750 - \$2,500 = \$55,250

Grades 9-12: \$62,950 - \$2,500 = \$60,450

- E-Pay via ACH: This feature can be accessed by logging into the parent portal, the web address is: http://www.harker.org/parents. Once logged in, please look for the tile titled "View and Pay My Bill". Please click on the "Pay My Bill" button in the Billing and Payment Hub. Once you are on the US Bank site, please register if desired and schedule the payment using your student ID number, which is located at the upper right of your billing statement.
